US TRADE AND INVESTMENT MISSION TO FIJI

SEPTEMBER 15-23, 2011

The Fiji Trade Commission (The Americas) invites businesses and interested individuals in the United States of America to participate in an **Official Trade and Investment Mission to Fiji** from September 15-23, 2011. Fiji's Trade Commissioner Mr. Jitendra Singh will receive the delegates on arrival in Suva on September 17, 2011.

The Mission will provide an excellent opportunity for US businesses/delegates to learn how to establish a new business, or expand their existing business with Fiji.

The program will include presentations on trade and investment issues by Government Departments and relevant authorities, such as Investment Fiji, Fiji Revenue & Customs Authority and the Reserve Bank of Fiji. A field trip to selected business in Fiji will also be arranged for interested participants.

There will also be an opportunity to interact with other businesses in Fiji, such as suppliers of Fiji's premium products, and to discuss joint ventures with Fijian businesses.

The Fiji Trade Commission will arrange presentations and individual meetings for participating businesses with Government Departments, relevant agencies and Fijian businesses in the final three days of the mission. These meetings can be used to present and discuss business proposals and seek specific clarifications in relation to the proposals.

Delegates are expected to bear their own travelling, accommodation and subsistence costs (except for any official lunches/dinners which are to be confirmed). The Fiji Trade Commission will provide ground transportation for domestic transfers and field visits.

A non-refundable registration fee of US\$50/participant will be required.

FLIGHT AND ACCOMMODATION OPTIONS

FLIGHT DETAILS

The official delegation will depart Los Angeles International Airport for Suva, Fiji on September 15, 2011 (LAX-NAN-SUV) and arrive in Suva in the morning of September 17. Trade & Marketing Officer for the Fiji Trade Commission, Mr. Colin King will accompany the delegation. Delegates arriving on September 17 will be provided ground transfers to the Holiday Inn and Tanoa Plaza Hotel in Suva. Fiji's Trade Commissioner, Mr. Jitendra Singh will receive the delegation in Suva.

It is not mandatory for delegates to travel with the official party on September 15 from Los Angeles. Those travelling separately on other days are nonetheless required to arrange their own transfers to their choice of accommodation and join the other delegates by 8.30am Monday September 19 at the Holiday Inn, Suva.

Travelling documents (passports and any necessary visas) are the responsibility of delegates.

Delegates are advised to purchase their own air tickets. The Fiji Trade Commission will try to arrange a reasonable discount on economy or business class airfares bought directly through Air Pacific Limited for **registered** participants. Depending on availability, partners/spouses travelling together with the delegates may qualify for a companion fare (buy one full priced economy ticket and get the second one for 50 percent (on the LAX-NAN route)). Registered delegates should contact the Fiji Trade Commission to arrange the discounts from Air Pacific Limited. Please note that while the Fiji Trade Commission will make all efforts to secure the discounted airfares, it does not guarantee them.

HOTEL DETAILS:
